

Mayor Julius Jones:

- Called the regular meeting of Council to order at 7:00 p.m. Present were Councilmembers Jeff Washington, Wanda Whetstone, Daniel Jackson and Jennifer Williams.
- Led Council and visitors in the Pledge of Allegiance.
- Declared quorum and welcomed all.
- Requested a motion to approve Council Minutes for September 14, 2020. Councilmember Washington motioned; Councilmember Whetstone seconded motion. All in favor. Motion passed.
- Welcomed Chief Lin Shirer to share the Police Report.

Chief Lin Shirer with the Police Report:

- Increased arrests of shoplifters and larcenies the last 30 days.
- Halloween night patrol neighborhoods and giving out candy. Asking for donated candy still. The Town is quartered for call/report reasons for the police department, at 6:30PM (until candy is gone or until 7:30PM) Town police will ride through each quarter to give out treats. Listen for the sirens and watch for the lights – children can come to the edge of the street or sidewalk and officers will distribute the treats, for citizens of the Town of North. Serves as an outreach for the Police Department. Costume contest for best costume, winner will be announced at the November Council Meeting.
- New patrol car reminder.
- Still looking for a resource officer. Reminder of how hiring process works – resume MUST be submitted to be considered.

Mayor Julius Jones on New Business:

- Financial reports.
- Mueller Receiver Kit upgrade fund have been received, \$6,000 to go towards cost.
- Water Tower on Stafford will be repainted on November 16, 2020.
- Flower bed at intersection of Hwy 321 and Hwy 178 is on railroad property. The bed will be removed by the end of the year.

Mayor Julius Jones's Mayor Report:

- Two water main breaks this month – one on Salley Road September 17<sup>th</sup> and one on September 25<sup>th</sup> at Camelia and Livingston. Both were repaired. Water testing came back clean.
- Asking for accounts to be updated with mailing addresses and contact numbers so that we are able to get ahold of affected accounts when emergencies happen.
- Family Health Centers Inc will be conducting COVID-19 testing the next two Wednesdays from 8:30am-3pm at the Town Square.
- Face mask policy is still in effect.

Mayor Julius Jones opened the floor for Council Projects:

- Councilmember Williams did not get the grant turned in before the deadline.
- Councilmember Whetstone has no update due to the pandemic.

Mayor Julius Jones asked if there were any questions. There were none.

Mayor Jones asked for a motion for adjournment:






- Councilmember Washington made motion to adjourn; motion seconded. All in favor. Unanimous. Meeting adjourned at 7:18PM.
